Job Duties

- Perform scheduled service on all combustion powered facility equipment.
- Perform maintenance repairs on all combustion powered facility equipment in a timely and safe manner.
- Report all facility mechanical deficiencies for maintenance and repair scheduling.
- Maintain mechanical workshops and storage facilities in a clean, organized and safe manner.
- Maintain an equipment service, maintenance and repair record.
- Various welding and fabrication needs related to bucket and machine repair.
- Responsible for tool inventory.
- Maintain suitable inventory of all needed supplies for regular servicing of all site mobile equipment.
- Be able to work in a team environment with Mechanics Helper/Welder.
- Participate in required testing and training programs including, but not limited to, WHMIS, TDG, confined space entry and rescue, fall protection, fire extinguisher use, first aid, mobile equipment awareness, aerial work platform, etc.
- General labour duties as required.
- All other duties as requested by supervisor or manager.

Requirements

- Minimum Education: High School or equivalent.
- 3 to 5 years' experience in a similar role.
- Knowledge of workplace safety and safe lifting and handling procedures.

Work Conditions
